- Aim is to have a system that can execute subset of functions available for testing by Marrakesh meeting
- USG asserted their right (as per contract) to decide how we implement software
- Public code needs to be reviewed for security, stability and reliability by agencies and general public.
  - Needs certified review by USG
- Hope to get NASK etc. involved in programming changes once requirements are met.

- ▶ Feb 21-Mar 7: USG seeks information on parties who can operate IANA function
- Mar 13: USG extends existing ICANN IANA contract to September 1.
- May 18: Announced plan to implement new 5 year contract to ICANN on July 17. (Comment period open until May 28.)
