On 10 September 2019, ICANN made a preliminary determination that operation of the .dodge gTLD need not be transitioned to a successor Registry Operator. On 06 November 2019, after a 30-day period for comments by interested parties, ICANN made a Final Determination to
	terminate the .dodge Registry Agreement and revoke the TLD's delegation from the Root Zone.
