Summary:	On 9 May 2017, McDonald's Corporation, the Registry Operator for .mcd, notified ICANN that it wished to terminate the RA citing its own business needs. On [Preliminary Determination Date], ICANN made a preliminary determination that operation of the .mcd gTLD need not be transitioned to a successor Registry Operator. On 9 May 2017, after a 30-day period for comments by interested parties, ICANN made a Final Determination to terminate the .mcd Registry Agreement and revoke the TLD's delegation from the Root Zone.
