Summary:	On 01 August 2019, FCA US LLC., the Registry Operator for .mopar, notified ICANN that it wished to terminate the RA citing its own business needs. On 10 September 2019, ICANN made a preliminary determination that operation of the .mopar gTLD need not be transitioned to a successor Registry Operator. On 06 November 2019, after a 30-day period for comments by
	interested parties, ICANN made a Final Determination to terminate the .mopar Registry Agreement and revoke the TLD's delegation from the Root Zone.
